I refer to you attendance at our office today where I requested that you had over the above cancelled certificate of title. You have not provided that document to me.

Instead, you expressed the view that:

- 1. The members of the Apostolic Christian Church obtained a new certificate of title pursuant to section 31 of the *Transfer of Land Act 1958* in the knowledge that the cancelled title was not lost and had not been destroyed. You claim that the members were able to lodge the section 31 application as they had wrongly appointed new trustees, and had forged a signature on the application.
- 2. The Registrar of Titles erred in granting the section 31 application and issuing the fresh certificate of title.

In response, I confirm my advice that:

- 1. Should you wish to take action against the members of the church, or the trustees, you must seek your own independent legal advice. In other words, this is not a matter for, and is of no concern to, the Registrar.
- 2. If you consider that the Registrar erred in granting the section 31 application, you must issue proceedings against the Registrar. I suggest that you seek your own independent legal advice in this regard also as I do not consider that the Registrar made an error.
